This year's speaker: Barry Kaufman

Barry was born on a small mixed farm in the Chilterns, where he developed an early interest in wildlife and nature. On leaving school he was fortunate enough to work for six years with the late TV naturalist and author Gerald Durrell at the Jersey Wildlife Preservation Trust (Jersey Zoo).

For 32 years Barry served as a Police Officer with Essex Police, including 22 years as a Wildlife Crime Officer with the force. In his role he dealt with many wildlife issues, from wild bird trapping to badger baiting, illegal shooting of wildlife to the multi-million pound international trade in endangered species and products from them.

Barry has graduated from the Open University with a BSc (Hons) Degree in Natural Sciences and a Post Graduate Diploma in Ornithology at Birmingham University.

In 2003 Barry won a prestigious award when he was named "WWF Wildlife Law Enforcer of the Year". This is an International Award presented either to a Police Officer or Customs Officer who in the view of a panel of distinguished judges has made a significant contribution to wildlife law enforcement. Barry is justly proud of his award.



Bishop's Stortford Neighbourhood Plan

Bishop's Stortford Town Council has overseen the development of a Neighbourhood Plan for the Silverleys and Meads wards of the town.

The Neighbourhood Plan allows residents of the town to have a direct say in the shape of new development. Due to government policy it is not possible to prevent new housing being built, but the local community can directly influence how it is built.

A Neighbourhood Planning team was formed of representatives of the communities in the wards of Silverleys and Meads, local residents, local councillors, local businesses, developers and volunteers. Agendas, Minutes of Meetings and other documentation can be found via the Bishop's Stortford Town Council website, in the Document Library under 'Neighbourhood Planning', http://www.bishopsstortfordtc.gov.uk/document-library. There are policies on Housing and Design, Green Infrastructure, Transport, Education, Health, Sport, and Business and Employment. Committee members of the Association made contributions to the Green Infrastructure policy.

Following a number of drafts the Neighbourhood Plan is now at the formal consultation stage, as required by Regulation 14 of the Neighbourhood Planning Regulations 2012 and is available for members of the public to view via the Neighbourhood Plan pages on the Town Council website. It can be downloaded in a variety of formats. Alternatively, the plan can be viewed at the Town Council Offices or a paper copy can be requested. Consultation started on 1 February 2014 and comments can be made via the Town Council website, by email to comments@stortfordplan.org or in writing to Bishop's Stortford Town Council, The Old Monastery, Windhill, Bishop's Stortford, Herts CM23 2ND (tel: 01279 652274) by 25 March 2014.

All Bishop's Stortford residents can comment on the Neighbourhood Plan: you do not need to live in the Silverleys or Meads wards. Take this opportunity to participate, and vote in the forthcoming referendum. If you don't, you have surrendered your only opportunity to have a say and make new development better for the town than it would otherwise be.

The formal consultation runs from 1 February 2014 to 25 March 2014. In May 2014 the plan will be submitted for independent examination, and it is hoped that the plan will go to referendum either late in 2014 or early 2015. Timing will be dependent on the examination stage.

Footpath added to the Definitive Map

The footpath that runs through Widford churchyard has been recognised as a public footpath and has been added to the Definitive Map. The County Council applied for a modification order in 2013 but this was turned down after the diocesan solicitor objected on the grounds that nobody owns a churchyard and so it wasn't possible to give implied dedication. This ruling was successfully appealed by the Ramblers Association using evidence from Acts of Parliament and other cases involving churchyard paths.

Whilst access to footpaths through churchyards hasn't been denied, a legal ruling that a Public Right of Way couldn't exist through a churchyard could cause problems when stiles or gates require maintenance or repair.

Beauty and Misery! Avoid the misery by joining a walk with one of our dedicated walk leaders.

Charity shops and old bookshops take me on journeys that I never knew I wanted to go on. Quite a few years ago I found a country walking book with a foreward by Ian Botham. "100 favourite walks down your way". There was one entitled "Round the Manor". 'This pleasant walk takes you past the beautiful grounds of Audley End House and also offers the opportunity to explore picturesque Saffon Walden.' Just the ticket.

I picked up the book and wrote out the instructions: a $4\frac{1}{2}$ mile walk $-2\frac{1}{2}$ hours, easy going, but slightly hilly on the longer route. Had quickly read, from Audley End station and then point 5 read 'bear right to walk up the approach road to the station.' Nowhere did it say.....do not walk on a Sunday. It was a Sunday. But I was a beginner to this walking lark (and still feel that I am) – but did take some water and a snack. My dog, George, likes a long walk and it sounded fun.

I didn't have a walk leader or even a map. But also minus compass and a mobile. It was only at Saffron Walden – sort of familiar surroundings. How difficult can it get? Off we went. First hurdle. Where was Wendon Road or even a footpath sign? It sounded so simple. 'Cross the River Cam and, at the end of a small spinney, bear left into a footpath leading along the edge of this.' There was a little brook, a lot of overgrowth and George was loving it. I only had written instructions and no map. When I got home I found that I had left out one of the first instructions – turn right. It would have helped. Eventually I did find myself in Saffron Walden. Quite a lot of retracing of steps and feeling as though I was in the jungle – I was either not on a footpath or this was one that not many people still walked.

Phew, in Saffron Walden. I love the feel of all the old buildings and there always seems to be something that I hadn't noticed before. People were admiring George and I was able to have a cup of tea and some refreshments. However, it was now clouding over. Not to worry though. I did have my rain mac with me and once I have decided to do a walk it always seemed that come rain or shine, I would have to tackle it head on. I was at point 4 – how much further could it be? – point 5 was the end of the walk. The rest of the walk promised a view of deer as one turned right onto a footpath signed to Springwell. So, refreshed and eager to get on - I might even get back in time to have a swim and Jacuzzi - easily found the footpath by the football club and followed the footpath that went uphill. On many occasions I have parked by the football club but had never realized that there was a footpath out into the countryside. The joys of walking, coming across somewhere new and such a lovely day to enjoy the peace and quiet of beautiful views.

I was looking for a track under the power pylons and the deer. Pylons seemed to now be everywhere – but in the far far distance. No matter how far I walked these did not seem to get nearer. We had a little rest. Now it was raining quite hard so put on rain mac. George was looking a little tired as well. Not sure where I went wrong but did finally find myself in Little Chesterford into Great Chesterford village. This was a euphoric and miserable moment as I had somehow convinced myself that I would miraculously end up at Audley End Rail Station. The penny dropped – a blonde moment as I realized that I must be doing the long walk now and surely this is quite a way from Audley End Station? But a road - civilization - can't be far now. It seemed too far away to totally retrace my steps. Cripes. This is nowhere near Audley End Station and I now find out that trains do not stop at Great Chesterford on a Sunday. I don't think I had enough cash for the fare anyway. It would seem that buses do not run along here either on a Sunday. George looks at me......how much further?

To cut a long story short I hadn't realized that some walks would not be 'circular'. That for a local walk, I needed a map. That footpaths were not always very clearly signposted. That I should have read all the directions and notes before I set out and so on. In my eagerness, on the spur of the moment, doing a 'pleasant walk' suitable for everyone would turn into such a nightmare. It seemed like misery at the time. Perhaps someone I knew would come to my rescue. I began to doubt that I was even walking in the right direction! You can imagine walking along from Great Chesterford to Audley End – with George now on his lead (not his idea of a pleasant walk). Finally we get back to Audley End and too late for the swim.

I have kept the book as a memento. It is supposed to remind me of how to prepare for a walk. So I am very appreciative of local associations who do keep our footpaths in good repair as this is not the only disaster that I have managed to encounter.

We liaise with local Planning and Highways authorities and monitor proposals affecting Rights of Way. The Association can and does protest, if necessary, at a Public Inquiry. We have published to date eight booklets recommending mainly circular walks of distances varying between 5 and 10 miles, the most recent in 2012. "Walks of the Month" are offered on our website. We lead weekend walks of 5-7 miles throughout the year. Details are found in the Walks Programmes published in the Newsletter and on the website. All are welcome.
